## AGELESS TAEKWONDO ACCREDITATION AGREEMENT

### 1. PARTIES

1.1. This is an Agreement (**Agreement**) between (**The Coach**) and Australian Taekwondo Limited (**ATL**).

### 2. COMMENCEMENT DATE

2.1. This Agreement commences on the date of signing by both parties.

### 3. ACCREDITATION CRITERIA

3.1. The Coach shall be responsible for the satisfactory delivery of the Ageless Taekwondo program (**Program**) and comply with all of the accreditation criteria set out in 3.1.1 to 3.1.6.

3.1.1. Ensure their Australian Taekwondo Club Talent Coach accreditation for first aid, police check, Sport Australia Harassment/ Discrimination certificates and ASADA Level 1 course are all up to date.

3.1.2. The Coach agrees to deliver the Program within the broad structure and curriculum outlined in the Ageless Taekwondo Program Instructor Guide.

3.1.3. The Coach agrees to abide by the Australian Taekwondo Codes of Conduct.

3.1.4. The Coach acknowledges and agrees that the Ageless Taekwondo Program Instructor Guide and videos are the intellectual property of ATL and are provided for the sole use of the Coach.

3.1.5. The Coach acknowledges and agrees that they will not transmit or copy by whatever means the Ageless Taekwondo Program Instructor Guide and videos or share it without the written consent of ATL.

3.1.6. The Coach will provide ATL with the requested participation and testing data as and when requested.

### 4. ACCREDITATION STATUS AND INTELLECTUAL PROPERTY

4.1. The Coach must ensure that they provide all documentation outlined in the Accreditation Criteria to maintain an active accreditation. Should any of the criteria fail to be met, it is the responsibility of The Coach to advise ATL in writing.

4.2. Where in the opinion of ATL, the Coach has failed to maintain an active accreditation for a period exceeding 2 months, ATL may at its sole discretion remove the Coach's accreditation from the Program.

### 5. PAYMENTS

5.1. The Coach shall be responsible for all payments related to the delivery of the Program. ATL will not make any payment to the Coach for any costs associated with the delivery of the Program, apart from assistance with funding equipment or venue hire. Such payments shall be in accordance with *The Ageless Taekwondo Equipment and Venue Funding Policy* and at ATL's sole discretion.

## 6. HEALTH AND SAFETY

6.1. The Coach shall take all measures to ensure that the Program is delivered with the safety, health and welfare of themselves and all participants in mind. The Coach shall advise ATL of any health concerns that could impact on their ability to deliver the Program to the expectations outlined in the Ageless Taekwondo Instructor Guide.

## 7. INSURANCE

7.1. The Coach shall ensure that Program participants are registered and insured with ATL as a component of their existing club membership package.

## 8. AGREEMENT EXECUTION
